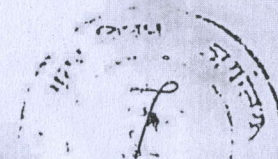
2. Address : The Registered Office of the Charitable Trust will be located at Ram Bhawan Palace, South Gandhi Maidan, Patna 800001.

3. Aim and objects of the Charitable Trust :

1. 4. (i) To establish and/or maintain and/or support by giving grants etc. to and for the benefit of the poor needy students and scholars, educational institutions, hospitals and such other health care schemes; relief to persons and institutions affected by natural calamities; welfare schemes and projects for the weaker sections irrespective of caste or the community in order to promote welfare, particularly population control education and national harmony in keeping with the highest ideals of the culture, heritage and upanishadic thoughts for the well being of the society and spiritual upliftment of the society at large.

(vii) Grant of endowment at Universities, Research Institutions (whether now existing or hereafter established) for spread of education and knowledge in all or any branches of knowledge.

(viii) To award scholarships and fellowships and grants by way of loan and otherwise to deserving candidates (including writers, journalists, lecturers and artists) on such terms and conditions and the Trustee may think fit for the purpose of undertaking, prosecuting and encouraging research work in any branch of learning like medical sciences particularly Ayurvedic and Bacteriology or agricultural science or any other branch or branches or modern applied sciences in its widest and more comprehensive terms.

(ix) To grant subscriptions and donations to Hospitals, Dispensaries, Convalescent Homes, Asylums, Nursing Homes, Orphanages, Aged Persons Homes and other public and charitable institutions or for administering medical relief to the needy upon such terms and conditions and for such period as the Trustee may think fit.

(xxi) All activities financed from the Trust's Fund be conducted in accordance with the ideals and objects as stated herein 3 (2) and no discrimination shall be permitted in the discharge of the social functions of the Trust i.e. excluding the functions mentioned in Para 3 (1) therein on grounds of religion, caste, creed or sex. Provided that any donations earmarked and accepted for any specific purpose falling within objects mentioned in these presents shall be used for such specific purpose only.

5. **Objects incidental or ancillary to the attainment of the above objects are:**

(i) To draw, make accept, execute and issue cheques, drafts, bills of exchange, promissory notes, bills of lading, warrants, debentures and other negotiable or transferable instruments or securities in connection with the activities of the trust.

(ii) To pay cost, charge and expenses of and incidental to the promotion, formation and registration of the trust.

(iii) To provide for the welfare of the employees or ex-employees of the company, their wives and families dependent by building or contributing to the building of houses or by grants of money, pensions, allowances, bonus, gratuity, compensation or other payments or from time to time by creating, subscribing or contributing to provident fund and other funds, medical and other assistance as the trust shall think fit.

(iv) To subscribe or contribute or grant money to any charitable benevolent religious social scientific national or other funds, institutions or objects and to

(v) To procure the registration or recognition of the trust in any country, state or place outside India and to establish and maintain local offices, branches and places of business in any part of the world.

(vi) To do all or any of the aforesaid things either as principals, agents, contractors, trustees or otherwise & either alone or in conjunction with others or by or through agents, managers and contractors or otherwise

6. The other objects of the trust not included in {3, 4 & 5} above of this clause for which the trust is established are:

(i) To promote and encourage on the business and trade of engineers, examiners, chemists, inventors, testers, analyses, developers, methoders, technicians, researches and manipulators and to set up, provide, equip and maintain laboratories, test house, research equipments, refrigerators, storage rooms, other preservators and conveniences of all kinds and descriptions for the production, manufacture, preparation, selling and distribution of every kind of medical, pharmaceutical and surgical products, materials and articles, injections, ampoules, capsules, tablets, tonics, fertilizers, manures, insecticides, agricultural, chemicals, soaps, toxins and anti-toxins, biological products, oils, lubricants, fuels, pigments, varnishes, paints, spirits, zoological products of every description and all other articles and things connected therewith or necessary for the purposes aforesaid.

7. BOARD OF TRUSTEE:

The Trustee named herein MAHARAJA BALABHAI M.P. SAHNI shall constitute of Board of Trustee Member of Governing Body who shall have the following powers:

- (1) The Board of Trustee may nominate his successor Trustee;
- (2) The Management & control and the Trust property of the Trust shall vest in the Governing Body;
- (3) The Managing Trustee shall be elected by the Members of the Governing Body.
- (4) In case of any difference of opinion amongst the Members of the Governing Body including the Managing Trustee in the decision making process of the activities of the Trust, the same shall be decided by majority view which shall not be less than 3/4.

8. Donations and Trust Fund:

The Trustee will be entitled to receive specified or otherwise donations from any person above the age of eighteen years as mentioned hereinbefore who accepts, unconditionally, the aims and objects mentioned in this Trust and agree to abide by the rules and regulations of this Trust.

9. Power to appoint Agent and Committees:

The Trustee shall be entitled from time to time to appoint Managers Directors, Officers, Agents or from Committees with or without remuneration and on such terms and conditions as he may think proper too function under the authority and control of the Governing Body for carrying out the Management of the Trust as per the direction of the Managing Trustee as may be necessary for carrying out the objects of other Trust.

10. Power to determine all questions of doubt or difficult :

It shall be lawful for the Governing Body to settle and determine all matters of interpretation of THESE PRESENTS as well as all matters of difficulty, doubt or dispute and all questions arising in the course of or incidental to the administration, management and execution of the Trusts and powers of THESE PRESENTS and any such settlement or determination (although the question involved may not have been actually raised) shall be valid binding and conclusive and shall not be objected to or reopened upon any ground, whatsoever.

11. Power to compromise and refer to arbitration:-

The Governing Body of the Trust shall have full power acting either as the Board or through its office bearers, agents etc. to settle, compromise or compound, out of court, all suits, actions and other proceedings and to settle all or other proceedings differences of demands to arbitration and adjust the settlement of all accounts relating thereto as fully as if they were absolutely entitled to the Trust Fund and without being answerable for the loss occasioned thereby.

12. Power of purchase-hire or take on lease :-



13. Power to Enter into Agreement :-

**14. Power to borrow :-**

To borrow or raise funds with or without security in a manner the Trust may think fit to repay the same with the approval of the Governing Body.

**15. Investment of Trust Fund :-**

All money forming part of the Trust Fund and requiring investment shall be invested in the name of the Trust for the time being in or upon any of the securities authorized by law for investment of Trust Funds or in deposits with any scheduled Bank or banks or Central, Provincial or District Co-operative Banks in India or in or upon the purchase of first mortgage of immovable properties situated in India or in debenture stock and shares of Public or Private Limited Companies, Mutual Funds incorporate in India which may be approved investments or others of a like nature or shall at their discretion sell and or realize the same or any part thereof, provided that the total investment in debentures, debenture-stock and shares as aforesaid shall not at any time exceed 50% of the total Trust Fund available for investment.

**16. In whose names moneys to be invested:-**

All moneys forming part or the Trust Fund and requiring investments shall be invested and the conveyance or the other assurance in respect of any immovable property or properties forming part of the Trust Fund shall be obtained in the names of the Trust for the time being of these presents.

**17. Opening of Banking Accounts :-**

The Trustee may from time to time open and maintain in the name of the Trust any Banking Account or Accounts with such Scheduled Bank or Banks as may from time to time be determined by the Governing Body and shall

and all other moneys forming part of the Trust Fund to the Credit of any such Account or Accounts shall be operated upon by such of the Managing Trustee/Manager/Officer/Agent as may from time to time be authorized to do so by the Governing Body of these presents.

**18. Accounts and Audit:-**

The Governing Body shall get maintained regular accounts of the Trust Funds and the same shall be audited by the auditor i.e. Chartered Accountant or a firm of Chartered Accountants for the above purpose and the Governing Body of the Trust shall have the power to appoint an Auditor or a firm of Auditors.

**19. Power to sell the immovable property and manage :-**

The Managing Trustee/Member of the Governing Body may sell or assign any movable or immovable property or properties for the time being forming part of the Trust Fund either together or in parcels and either by public auction or private contract and either with or without any special or other stipulations as total evidence of commencement of title or otherwise and to buy in and rescind or verify and contract for the sale and resale without being made answerable for the loss occasioned thereby and for the purposes aforesaid or any of them to execute and do all such assurance, acts, deeds and things as they shall deem fit and by and out of the money which shall from any such sale or otherwise in or about the execution of any of the trusts or powers of these presents and shall stand possessed of the residue of the said moneys and also the rents and profits of the said premises or of the unsold part thereof for the time being upon such Trust and subject to such powers, provisions,

agreements and declarations as may be required. Provided, always that the Governing Body shall manage any immovable property or properties for the time being forming part of the Trust Fund or belonging to the aforesaid family deities of which this Trust and its Managing Trustee are custodians and managers in such manner as they shall think fit with full power to make improvements, repairs or alterations of any description and to make or incur any outlay for any such purposes or for ~~the insurance~~ or otherwise for the protection or benefits of the said premises and to grant or renew leases of any description and upon any terms of the said surrenders or leases and agreements (either in contemplation of a renewal lease or tenancy or otherwise) or to alter the same respectively, and to make any allowances to or agreements with tenants or occupiers or intending tenants or occupiers of the said premises and it shall be in the discretion of the Managing Trustee/Governing Body either to prosecute or ~~forbear or to compound~~ or submit to arbitration or settle in any other manner and if thought fit altogether to give up and release any remedies or demands against tenants or occupiers or any other persons or person whatsoever in relation to the premises.

**20. Receipts of Trustee:-**

The Receipts in writing of the Managing Trustee or the authorized Officials for the time being of these presents for any interest dividend or income of the Trust Fund or pertaining to the properties and assets of the family deities aforesaid or for any deeds, papers, written documents or other moneys and effect payable or deliverable to the Managing Trustee and/or the authorized officials of the trust shall be sufficient and effectual discharge for the same respectively as in such

The Managing Trustee and/or the Governing Body may also authorize any Bank, Scheduled Bank or provincial or district co-operative bank in India to collect any interest, dividend or income of the Trust Fund on their behalf.

**21. Power to amend the rules:-**

**22. Power to make rules and regulations :**

In addition to the aforesaid rules the Managing Trustee/Governing Body shall from time to time, be entitled to make rules and regulations for the administration and management of the Trust of these presents and all matters incidental to or concerning the same provided such rules and regulations shall not be

The Members of the Governing Body discussed about the necessity for the Amendments in the Registered Deed of Declaration, bearing Documents No: 2505 executed on 16.09.2005 due to the various changes in the Income-tax Act as the Trust had applied for Exemptions under the Income-tax Act. Shri S. R. Mishra, Member of the Committee informed the Committee that in our meeting held on the 24<sup>th</sup> December, 2013 we had changed the name of the Trust by omitted the word 'PRIVATE' from the name of the Trust and also the situation of Registered Office of the Trust which was published in the Local Newspapers on the 10<sup>th</sup> July, 2014 in the AAJ( in Hindi ) and 11<sup>th</sup> July, 2014 in the TELEGRAPH( in English). The Members discussed in detail and approved and accepted the suggestions of Shri Mishra and accordingly the Deed of Declaration dated 16.09.2005 be modified and in continuation of previous Deed of Declaration a fresh Deed of Declaration by incorporating the new clauses as per I.T. Act may be executed. After discussion the following decisions have been taken:

"RESOLVED THAT the following amendments/modification in the Registered Deed of Declaration be and are hereby amended/modified as under :

- The word 'PRIVATE' wherever is mentioned in the Registered Deed of declaration be withdrawn/deleted;
- Existing Clause No: 7 shall be replaced and to be now read as follows :

"The Trustee named herein, Maharaja Bahadur Mrigendra Pratap Sahi shall constitute a Board of Trustee/ Members of Governing Body who shall have the following powers:

- The Board of Trustee may nominate his successor Trustee;
- The Management & control and the Trust property of the Trust shall vest in the Governing Body;
- The Managing Trustee shall be elected by the Members of the Governing Body;
- In case of any difference of opinion amongst the Members of the Governing Body including the Managing Trustee in the decision making process of the activities of the Trust, the same shall be decided by the majority view which shall not be less than 3/4.
